Whereas, the Board while considering your representations decided to release the selection after seeking verification of original RBA certificates from the Deputy Commissioner concerned.

Therefore, through the medium of this notice you are directed to appear before the Secretary, J&K Services Selection Board, Hema Complex, Sector 3 Channi Himmat, Jammu alongwith all original documents on the basis of which you have claimed the benefit of RBA category by producing valid within cut-off date RBA category certificates within 07 days from the date of issuance of the notice, failing which your candidature for the post of Jr. Assistants under Item No. 151 shall be rejected without any further intimation.
