7. 10+2 Marks Sheet / Diploma, if applicable.
8. Bonafide certificate on the format prescribed by the Board duly issued by the Controller/Registrar of the concerned University in respect of candidates, who have obtained Degrees from the Universities / Colleges/ Institutes outside the UT of J&K and other than Central Universities.
9. Migrant Certificate issued by Relief & Rehabilitation Commissioner.
10. Other documents and Certificates as prescribed in the Advertisement Notification and Qualification prescribed therein.
11. ITI Motor Mechanic Vehicle of two years course from any recognized Institute.
12. Driving License of Motor Cycle with Gear (MCWG) and Light Motor Vehicles (LMV).
