"The grievance of the petitioners in this case is that despite the direction of the Court, the respondents have not allowed him to examine his attendance record regarding the interview conducted by the respondents

Learned counsel for the petitioners submits that the orders have not been complied with so far since despite notices, and the petitioner did not report to the Services Selection Board. He submits that notices seem to have been issued on the wrong address and therefore, they were not intimated by the respondents. According to the counsel of the respondents, the petitioners would be permitted to examine the attendance record with regard to the interview conducted for the post on question."


