**Subject: Submission of Affidavit for Selection against the posts of Accounts Assistant (Finance Department), UT Cadre, advertised vide Advertisement Notification No 04 of 2020, Under Item No 106, regarding one-time benefit of reservation as Ex-Servicemen.**

Whereas, the JKSSB vide office Notice No.SSB/Secy/AAF/2022/4261-67 dated 11-05-2022 called candidates falling under consideration zone for the posts Accounts Assistant (Finance Department), UT Cadre, advertised vide Advertisement Notification No 04 of 2020, Under Item No. 106 for Documents Verification, and;

Whereas, **Rule 2 (Explanation II)** of the Jammu and Kashmir Ex-servicemen (Re-employment in Public Services and Posts) Rules, 2021 notified vide **SO 361 dated 20-10-2021 envisages as under: -**

***"An ex-serviceman on joining any post after having availed Horizontal Reservation, cannot avail of the benefit of reservation as Ex-Serviceman for any subsequent employment."***

Now therefore, in view of the above, all such candidates who have been called for Documents Verification for the post of AccountsAssistant (Finance Department), UT Cadre, advertised vide Advertisement Notification No 04 of 2020, Under Item No 106,under **Ex-Servicemen category**, are hereby directed to submit an undertaking in addition to other requisite documentsin the offices of Jammu and Kashmir Services Selection Board. **The undertaking should be in the shape of an Affidavit duly attested by a Ld. Judicial Magistrate 1<sup>st</sup> Class to the effect that:**

- (a) He/she has not availed anybenefit of Horizontal Reservation as Ex-Serviceman in a civil post earlier.**
- (b) If at any stage of the selection or later on, it was found that he/she has already availed any Horizontal Reservation, benefit of reservation as Ex-Serviceman, his/her candidature shall be cancelled ab-initio, without any further notice and he/she shall have no objection if his/her name for the said post be rejected.**

All such candidates shall deposit the affidavits /undertaking in the**Central Office of the J&K Services Selection Board, at Hema Complex, Sector -3, Channi Himmat, Jammu or Zum Zum Building, Rambagh, Srinagar, by or before**

**10-06-2022**, failing which no claim in this regard shall be entertained and the J&K Services Selection Board shall take further necessary action in the matter under rules.
