Whereas, the J&K Services Selection Board (JKSSB), vide Notification No. 01-Selection of 2024 dated 8 of January, 2024, issued under endorsement No. JKSSB-Scry/26/2023-03(E-7376857), notified the Final Selection List for the posts of Sub-Inspector, Police (Home Department), advertised vide Notification No. 06 of 2021 dated 21.10.2021 and Notice No. SSB/Secy/2021/7926-42 dated 24.11.2021 and forwarded the recommendation of 1102 candidates to the Home Department vide letter No. JKSSB-Scry/26/2023-03(E-7376857) dated 10.01.2024; and

Whereas, in the aforesaid Final Selection List, among others, the candidature of 14 candidates, making it to the consideration/selection zone under Social Caste Category, was kept reserved as they were in possession of OBC Certificates (certificates issued on central format), instead of the requisite OSC Certificate; and

Whereas, some candidates represented in the General Administration Department, which took up the matter with the concerned departments i.e. Revenue Department, SWD and Department of Law, J&PA; and

Whereas, the General Administration Department, vide letter No. GAD/MTG0RB-IV/07/2024(7378804) dated 30.04.2024, forwarded a copy of opinion received from the Social Welfare Department bearing No. SWD-Resv/1/2024-02 dated 23.04.2024 and advised the Board to proceed in the instant matter accordingly, after consideration in full Board Meeting; and

Whereas, the matter was deliberated in the 272nd Board meeting, held on 17.05.2024, which decided to proceed in light of the opinion of the Social Welfare Department/Law Department, as conveyed by the General Administration Department vide letter No. GAD/MTG0RB- IV/07/2024(7378804) dated 30.04.2024 and to accept the



Category Certificates which bear the following clarification/remarks, as per the advisory from the Revenue Department, with seal and signature of the concerned issuing authorities (Revenue):

"Duly verified; this certificate should be considered as a validly issued OSC certificate, the validity of which shall be calculated from its date of issuance."

Whereas, all fourteen candidates under Social caste Category, whose candidature was kept reserved for the aforesaid posts of Sub-Inspector (Home), submitted the requisite duly validated category certificates containing the above remarks from the concerned issuing authorities; and

Whereas, the issue along with the re-validated certificates was placed in the 273rd Board Meeting, wherein the Board decided to fill-up the said 14 Social Caste Category reserved posts, subject to satisfactory medical examination of the said candidates; and

Whereas, vide Notice issued under Endorsement No. JKSSB-Scry/26/2023-03(E-7376857) dated 29.05.2024 and letter No. JKSSB-Scry/26/2023-03 (E-7376857) dated 29.05.2024, the 14 candidates were referred to the Medical Boards for undergoing their medical examination; and

Whereas, upon receipt of satisfactory medical reports in respect of these candidates received from GMC Jammu vide communication No. GMC/21/SMBC-SI/3220 dated 06.06.2024, the matter was placed before the Board in its 275th meeting, which after deliberations and consideration of the matter, decided to fill up the reserved posts by considering the candidature of the candidates having been declared as fit by the designated Medical Board and forward the same to the indenting department.

Now, therefore, it is hereby notified that:

i. the candidates featuring in **Annexure-A** to this Notification shall figure against the reserved posts (at the serial as indicated against each) in the Final Selection List notified for the posts of Sub-Inspector, Police (Home Department), UT Cadre, notified vide Notification No. 01-Selection of 2024 dated 8 of January, 2024, issued under endorsement No. JKSSB-Scry/26/2023- 03(E-7376857) and advertised vide Notification No of 2021



dated 21.10.2021, read with Notice No. SSB/Secy/2021/7926-42 dated 24.11.2021.

ii. the above selection of the candidates shall be subject to outcome of the OAs/Writ Petition(s), if any, pending adjudication before any Competent Court of law and shall also be subject to the outcome of any pending enquiry, involving candidate(s).

iii. the Selection of the candidates has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage.
