**ORDER No. 41- SSB OF 2023
DATED:- 20 -02- 2023**

Subject: - O.A 258/2021 titled Abhiv Koul Vs UT of J&K and others.

Whereas, the J&K Services Selection Board forwarded a Select list of the candidates for the post of VLW District Cadre Budgam vide this office letter No. SSB/ Secy/Sel//101/(M)2019/1746-48 dated 06-03-2020 to the Department of Disaster Management Relief & Rehabilitation Reconstruction under Prime Minister's Special Package for Kashmir Migrants in pursuant to Advertisement Notification No.04 of 2017,Item No.073; and

Whereas, the recommendation of one candidate namely **Abhiv Koul S/o Vijay Kumar Koul under RBA Category** was kept withheld subject to production of valid within date RBA category certificate; and

Whereas, in the aforesaid Selection List, it was mentioned that the candidates whose recommendations has been kept withheld shall submit the requisite documents within 30 days from the issuance of the list, positively; and

Whereas the aforesaid candidate namely Abhiv Koul submitted the RBA certificate issued vide order No.03/RRCM/RBA/19-20/02 dated: 08-06-2019 and the RBA certificate submitted by the candidate clearly indicates that the RBA certificate submitted by the candidate has been issued after the cut-off date i.e **22-12-2017**; and

Whereas, the matter was placed before the Board in its 177th Meeting and the candidate namely Abhiv Koul was declared as "**Not Eligible**" and accordingly vide Order No 36-SSB of 2021 dated 22.01.2021, the withheld selection of the candidate has been cancelled/withdrawn ab-initio ; and

Whereas, the applicant filed OA before the Hon'ble Central Administrative Tribunal, Srinagar and the Hon'ble Tribunal vide order dated 05.09.2022 disposed of the OA with the following directions:-

" the O.A is allowed and respondents are directed to consider the RBA certificate submitted by the applicant and are directed to issue the appointment order in favour of the applicant as VLW under RBA category on the basis of merit secured by the applicant in the selection process. This exercise shall be completed within two weeks from the date of receipt of certified copy of the order. O.A No. 258/2021 is disposed of accordingly."

Whereas, the case of the applicant was considered in compliance with the directions passed by the Hon'ble Tribunal and it is found that the certificate submitted by the candidate has been considered by the Board and the recommendation of the candidate has been cancelled/withdrawn ab-initio. Further, the selection process has already been concluded and forwarded to the Indenting department for further action.

Now, therefore, in due deference to the order dated 05.09.2022 passed by the Hon'ble Tribunal, Srinagar, the claim of the petitioner namely **Abhiv Koul S/o Vijay Kumar Koul** has been considered and found devoid of merit, is hereby rejected.
