Order No. 211 _SSB of 2022

Dated: 23 06.2022

Subject: - Hon'ble Central Administrative Tribunal Order dated 18.05.2022 passed in OA 426/2022 titled Naseer Ahmad Gojer Matravi Vs J&K Services Selection Board and Anr.

Whereas, the General Administration Department vide Indent No.GAD/MTG/RB-IV/50/2020 dated 22.06.2020 requisitioned 8575 Class-IV posts pertaining to various Department for recruitment in accordance with the provisions of Jammu and Kashmir Appointment to Class-IV (Special Rules 2020) notified vide SO 184 of 2020 dated 04.06.2020 read with SO 193 dated 17.06.2020 and other relevant rules governing the subject; and

Whereas, these 8575 Class-IV posts for District/Divisional/UT Cadres in various Department were notified vide Advertisement Notification No. 01 of 2020 dated 26.06.2020; and

Whereas, the post notified include posts under all the reserved categories as envisaged in SRO 294 of 2005 read with SO 127 of 2020 including posts reserved for SC and ST candidates and it was well mentioned in the para 7 (1) of Notification No. 01 of 2020; and

Whereas, the Board issued Advertisement Notification No. 01 of 2020 dated 26.06.2020, inviting therein applications for the Post of Class-IV. The applicant herein applied for the post of Class-IV and competed in the selection process and was provisionally selected and accordingly was called for Document Verification vide Notification No. SSB/Sel/Secy/2022/2601-10 Dated: - 12.03.2022 on 18.03.2022 ; and

Whereas, the candidate namely Naseer Ahmad Gojer Matravi whose Document Verification was scheduled on 18.03.2022 failed to appear for the Document Verification on the scheduled date and even has not approached the Board for the same during the process of Document verification which was conducted upto 24.03.2022; and

Whereas, the applicant approached the Hon'ble Central Administrative Tribunal by way of O.A. No. 426/2022 for direction to allow him to submit File No.JKSSB-LEG/150/2022-05-SERVICE SELECTION BOARD (OUTSIDE SECTT) Documents for Verification and to consider his candidature for selection and appointment to Class-IV Post, and;

Whereas, the Hon'ble CAT vide order dated 18.05.2022 passed an order, the operative part whereof reads as under:

"...In view of the limited prayer made by the learned counsel for the applicant, O.A. is disposed off at the admission stage with


direction to the respondents/ competent authority to consider the pending representation of the applicant dated 7.4.2022 (Annexure No.VII to the O.A.) along with averments made in the present O.A. and dispose off the same, by passing a Reasoned and Speaking order, within a span of 2 weeks from today and decision so taken shall be communicated to the applicants forthwith.....; and

Whereas, the matter has been examined by the Board with reference to record and the rule position and it has been found that the applicant has missed the opportunity to appear before the Document Verification committee. Document verification was continuing upto 24.03.2022 and the applicant has neither represented nor appeared before Document Verification Committee during the said period. The applicant represented before the Board on 07.04.2022 i.e., after a gap of 20 days from the date on which Document verification of the applicant was scheduled. At that time, the process for document verification was culminated and the Selection Committee was under the process of preparation of selection list, as such, the request made by the applicant through representation dated 07.04.2022 was not considered as being time barred and infructuous and;


Whereas, openness and transparency are essential for maintaining sanctity and level playing field in the selection process and that the Board cannot adopt selective and 'pick and choose' policy for granting consideration to candidates. Further, besides being unjust and iniquitous, the selection process will become a never ending affair and cannot attain finality.

Now, therefore, in compliance with the directions of the Honble Central Administrative Tribunal and having regard to the facts and circumstances explained hereinabove with particular reference to the failure of the applicant, the claim of the applicant has been considered by the Board with reference to the record and the Rule position and found that the applicant has miserably failed to appear before the Document Verification Committees when ample and sufficient opportunity was provided to the candidates and File No.JKSSB-LEG/150/2022-05-SERVICE SELECTION BOARD (OUTSIDE SECTT) found bereft of any merit, and as such is rejected
