Subject: - Hon'ble Central Administrative Tribunal Order dated 28.04.2022 passed in OA 352/2022 titled Mahraj Ud Din Bhat Vs UT of J&K & Ors..

Whereas, J&K Services Selection Board, vide Advertisement Notification No. 04 of 2020 dated 16.12.2020, invited applications for selection to different posts under District/Divisional/UT Cadre posts which inter-alia includes the post of Motor Vehicle Traffic Assistant under item No. 095,091 and 086,and,

Whereas , the J&K Services Selection Board, issued advance notice vide No.SSB/COE/CBT-II/2021/6350-60 dated 27.09.2021 for conduct of computer based written examination for various posts w.e.f 27.10.2021, onwards, and,

Whereas, as per database two Roll No.'s were systematically generated in favour of (the applicant) for appearing in the CBT examination which were later on clubbed at the time of declaration of result of the CBT examination, and

Whereas, aggrieved of his non consideration for the post, the applicant herein, has approached the Hon'ble Tribunal by way of filing OA No. 352/2022 titled Mahraj Ud Din Bhat Vs UT of J&K & Ors.and,

Whereas, the matter came up before the Hon'ble Tribunal on 28.04.2022 and the Hon'ble Tribunal upon hearing the OA, disposed off the same as under:-

In view of the limited prayer made by the learned counsel for the applicant, O.A. is disposed off at the admission stage with direction to the respondents/ competent authority to consider the pending representations of the applicant dated 8.11.2021 and 16.12.2021 along with contents of the present O.A. and dispose off the same, by passing a Reasoned and Speaking order, within a span of 4 weeks from today and decision so taken shall be communicated to the applicants forthwith.and,

Whereas, the case of the applicant was examined by the Board along with representations dated 08.11.2021 and 16.12.2021 and it came to fore that two Roll No.'s were systematically generated to the applicant for appearing in the CBT examination which, were later on clubbed at the time of declaration of result of the CBT examination, besides it was also found that applicant has secured 22.284434490 percentile in the CBT examination while as last cut off percentile under OM category for document verification is 71.67.

Now, therefore, in compliance with the directions of the Honble Central Administrative Tribunal dated 28.04.2022 and having regard to the facts and circumstances explained hereinabove with particular reference to the clubbing of Roll No's and failure of the applicant to make grade for document verification, the claim of the applicant has been considered by the Board with reference to the record and the Rule position and found bereft of any merit, and as such is rejected.
