**Subject:-Part Selection List of candidates for the post of Fisheries Development Assistant Animal & Sheep Husbandry Department, Item No. 016 (03 of 2017) Division Cadre Kashmir.**

Sir,

The Animal & Sheep Husbandry Department requisitioned 06 posts of Fisheries Development Assistant Division Cadre Kashmir vide indent No. ASHF/Coord/Fish/23/2011 dated 22.09.2017, the breakup of the said posts is given as under:-

As per indent provided by the indenting department, the prescribed qualification for the said post is as follows:

***"B.F. Sc or B. Sc Medical with Zoology or B. Sc Industrial Fish & Fisheries from any recognized university/institute".***

The said posts have been notified by the Board vide Notification No. 03 of 2017 dated 17.11.2017 with cut-off date of acquiring eligibility/filling of application forms as 11.12.2017. The process of interview has been dispensed with for this Item/post in light of Govt. Order No. 255-GAD of 2018 dated 14.02.2018, however written examination (CBT) was held from 8<sup>th</sup> of April to 15<sup>th</sup> of April 2018 and accordingly a provisional shortlist was issued by Board vide Notification No. SSB/Secy/Sel/2018/3641-45 dated 05.06.2018; and document verification of the shortlisted candidates was held on 18.07.2018. The Selection list for the said post in respect of OM, RBA and SC categories along with waiting list was forwarded to Animal & Sheep Husbandry Department, Civil Secretariat, Jammu vide this office letter No. SSB/Secy/Sel/2019/306-12 dated 09.01.2019, but selection list in respect of ST category was deferred in view of superior



claim of one candidate namely **Tsewang Lamo (ST category)** who was required to be called for counselling/verification of documents.

In the meantime one candidate namely **Shazia Shah** approached the Hon'ble High Court through the medium of writ petition in SWP No. 21/2019 titled "**Shazia Shah V/s State of J&K and others**" requesting for issuance of selection list of Fisheries Development Assistant under ST category however the Services Selection Board in its reply filed before the Hon'ble High Court denied the claim of the petitioner as one candidate namely **Tsewang Lamo**, who had also applied for the post and having higher merit than the petitioner, inadvertently was not called for document verification, as such the post under ST category was kept reserved

The petition was transferred to the Hon'ble Central Administrative Tribunal (CAT) Jammu in TA NO. 5131/2020 and Diary No. 7940/2020 and the Hon'ble Tribunal vide its order dated 15<sup>th</sup> of April, 2021 passed an order, the operative part of which is as follows:

***"...We, therefore, dispose of this TA, directing the appointing authority to finalize the selection and appointment to the post of FDA, reserved in favour of ST, referable to the advertisement dated 17.11.2017, within a period of four weeks from the date of receipt of a copy of this order, strictly in accordance with the merit among the ST candidates, whose social status is beyond any pale of doubt. The MA for implement of the proposed respondent no. 4 is allowed. There shall be no order as to costs".***

In compliance with the directions of the Hon'ble Central Administrative Tribunal, a notice was given to Ms. **Tsewang Lamo D/O Rigzan Angchuk R/O Leh Ladakh** vide No. SSB/Secy/Sel/2021/7447-49 dated 01.11.2021 directing her to appear before the Secretary, J&K Services Selection Board, Jammu within a period of 15 days alongwith the all requisite documents in support of her claim, so that Board is in a position to finalize the selection for the post of Fisheries Development Assistant

In pursuance of the said notice, the candidate **Tsewang Lamo D/O Rigzan Angchuk R/O Leh Ladakh** appeared before the Secretary, JKSSB Jammu on 08.11.2021 along with all original documents which have been seen by the Secretary, JKSSB.



In view of the above facts and circumstances, the selection list prepared, in light of the criteria adopted by the Board under relevant rules and on the basis of merit obtained by the candidate, was approved by the Board in its 194th Board meeting held on 17.12.2021 and is hereby forwarded herewith as **Annexure "A"**, in respect of ST category candidates comprising of 01 candidate in selection list and one candidate in waiting list.


Further, the list notified shall be subject to the outcome of writ petition (s) (if any) pending disposal before any competent Court of jurisdiction related to the selection.

The document verification/ scrutiny conducted by the Board is limited to the extent of establishing physical possession of category/degree and ascertaining recognition status of institutes, genuineness/validity etc. or otherwise of the degree/category shall be responsibility of the Indenting Department/appointing authority.

You are further requested that in case any certificate/document, during the course of verification, turns out to be fake/fictitious, the Board may kindly be kept posted and appropriate criminal proceeding against such candidates may please be initiated.
