Consequent upon the indent/requisition received from the Health & Medical Education Department vide No. ME/NG/53/2018-PF dated 10.01.2019 for 08 posts of "**Radiography Technician**", (**Health and Medical Education Department** (GMC Baramulla), **Divisional Cadre Kashmir**, the advertisement notification in respect of said posts was issued by the Board vide Notification No. **02 of 2019** under Item No. 011, with below mentioned category wise break up: -

Pursuant to aforementioned advertisement notification, the Jammu and Kashmir Services Selection Board (JKSSB) conducted Computer Based Test (CBT) for the above said post on 11th of May 2019. On the basis of performance of the candidates in the Computer Based Test, provisional selection list was issued by the Board vide Notification No. SSB/Secy/Sel/2019/5160-66 dated 05.10.2019 and 40 candidates were called for document verification/counselling on 31st of October and 2nd. of November, 2019. The list was prepared and forwarded to the Health and Medical Education Department vide this office letter No. SSB/Secy/Sel/26/K/ 2020/2352-58 dated 16.03.2020. The selection process to the post of "**Radiography Technician**" has been subject matter of SWP No. 604/2020 titled "Ajaz Ahmad Ahanger & others V/s Union Territory of J&K & others" in the

Hon'ble High Court of J&K. The Hon'ble court vide its order dated 03.03.2020 passed the order, the operative part of which is reproduced as below:-

"...In the meanwhile, subject to objections and till next date of hearing, the selection of private respondents 07 to 21 shall not be given effect to."

Subsequently the case was transferred to the Hon'ble Central Administrative Tribunal, Jammu in TA No. 62/7196/2020 titled Ajaz Ahmad Ahanger & others V/s UT of J&K & others and the Hon'ble Central Administrative Tribunal vide its order dated 25.10.2021 dismissed the TA 62/7196/2020 and passed the following order:-

"...We do not find any merit in the TA, which is accordingly dismissed. There shall be no order as to costs."

The said judgement of Hon'ble Central Administrative Tribunal was challenged before the Hon'ble High Court of Jammu & Kashmir and Ladakh at Srinagar in WP (C) No. 2251/2021 titled Ajaz Ahmad Ahanger and others V/s UT of J&K and others. In the above said writ petition, the Hon'ble High Court on 16.11.2021 passed the following order:-

"...For the foregoing reasons, we don't find any error or illegality in the impugned judgement passed by the Tribunal. The impugned judgement of the Tribunal is well reasoned and lucid. The same does not call for any interference. The writ petition lacks merit and the same is accordingly, dismissed."

Considering all the facts and circumstances of the case together with the aforesaid orders of the Hon'ble High Courts and Hon'ble Central Administrative Tribunal (CAT), the part selection list along with waiting list in respect of posts/slots kept reserved, in relation to the post of **"Radiography Technician"** was prepared and placed before the Board in its 193rd Board meeting held on 03.12.2021. In pursuance of the approval of the Board, the part selection list for the post of **"Radiography Technician"** was notified vide notification No. SSB/Sel/Secy/2021/8412-17 dated 04.12.2021

The Selection List as mentioned above shall be subject to outcome of the writ petition(s) (if any) pending disposal before any competent Court of jurisdiction related to the selection.


