Subject: Selection List of candidates for the posts of Deputy Inspector Fisheries/Equivalent (Level 4; Item No. 656: Div Jammu; Item No. 657: Div Kashmir, Divisional Cadre posts), Animal/Sheep Husbandry and Fisheries Department, advertised vide Notification No. 04 of 2021 dated 17.07.2021-Release of recommendation reg.

Sir,

Kindly refer to this office letter No. JKSSB-Scry /18/2023-03(7325184) dated 09.01.2024 regarding the subject cited above, where-under the Selection List for the post of Deputy Inspector Fisheries/Equivalent (Level 4; Item No. 656: Div Jammu; Item No. 657: Div Kashmir, Divisional Cadre posts), Animal/Sheep Husbandry and Fisheries Department, advertised vide Notification No. 04 of 2021 dated 17.07.2021 was forwarded to your department for further course of action.

Among the selectees, one post of Deputy Inspector Fisheries/ Equivalent, Level-4; (Item No. 656: Div. Jammu) at serial No. 01 under EWS category was kept reserved for the reason that the candidate who was figuring in the provisional selection list under EWS category was not making it to the final selection list for the reason that the Deputy Commissioner, Ramban vide letter No. ADMR/746-47 dated 28.12.2023 furnished that the EWS certificate issued in favour of Sh. Mohd Imran Naik is applicable for the Central Services only, as the village Doligam also falls under Backward Area (vide SRO 294 of 21.05.2005).

In order to ascertain the eligibility of next in merit, Mr. Kuldeep Kumar S/o Dewan Chand R/o Lopara Dachhan, Kishtwar, the Board vide letter No. JKSSB-Scry/18/2023-03 (E-7325184) Dated 25.01.2024 request the Deputy Commissioner, Kishtwar to clarify whether the EWS certificate issued in favour of Mr. Kuldeep Kumar can be considered for the UT level post of "Deputy Inspector Fisheries" or otherwise. In response, the DC, Kishtwar vide his communication No.DCK/PS/24/268 dated 29.04.2024 furnished that the said person belong to socially and educationally backward class (RBA) area, as defined under clause (o) of Section 2 of the J&K Reservation Act, 2004 which is not recognized on central list so, the EWS certificate issued in favour of Kuldeep Kumar on the central format bearing No. 28/TD/OQ/EWS dated 25.03.2021 by the then Tehsildar can be considered for Central Jobs/Institution only.

Mr. Deepak Sharma S/o Chander Parkash R/o Rehan Peeri Tehsil Kotranka District Rajouri, next in merit under Item No. 656, EWS category was also in possession of an EWS certificate on central format.

The matter was examined by the Board and vide letter No. JKSSB-Scry/18/2023-03 (E-7325184) dated 04.07.2024, the issue was taken up with the Deputy Commissioner, Rajouri for clarification. In response, the Deputy Commissioner, Rajouri, vide letter No. DCR/2024-25/GS/VR/585 dated 22.08.2024, while enclosing the report of Tehsildar Kotranka vide letter No. TK/N/2024-25/109 dated 08.08.2024 furnished that the category

certificate of the candidate namely Mr. Deepak Sharma S/o Chander Parkash R/o Rehan Peeri Tehsil Kotranka District Rajouri has been issued vide office No. JA/807 dated 07.06.2021.

In line with the Board decision taken in 293rd meeting, the case was further examined by the Selection Division in light of the clarifications issued by Tehsildar Kotranka (Budhal) vide letter No. TK/N/2024-25/538 dated 19.11.2024 submitted by the candidate, which provided as under:

In continuation of communication No. TK/N/2024-25/109 dated 08.08.2024, it is hereby clarified that Sh. Deepak Sharma S/o Chander Parkash R/o Rehan has been issued EWS certificate issued in his favour vide office No. JA/807 dated 07.06.2021 and the said individual did not possess any other categories mentioned in clause (m) (n) and (o) of the Jammu and Kashmir Reservation Act, 2004.

The case was further examined in the Selection Division and was placed before the Board in its 295th Board meeting, which after perusal of all the documents related to the case, decided as under:

The Board deliberate the issue threadbare and on the basis of record produced, decided to recommend the candidature of Mr. Deepak Sharma S/o Chander Parkash R/o Rehan Peeri Tehsil Kotranka District Rajouri-185132 being the candidate next in order of merit in EWS category for post of Deputy Inspector Fisheries equivalent, Level-4; (Item No. 656; Div. Jammu), at Serial No. 1 under EWS category which was kept reserved.

Accordingly, the undersigned is directed to convey the above decision regarding Mr. Deepak Sharma S/o Chander Parkash R/o Rehan Peeri Tehsil Kotranka District Rajouri, figuring at serial No. 1 under EWS category for the post of Deputy Inspector Fisheries in Animal/Sheep Husbandry and Fisheries Department, advertised vide Notification No. 04 of 2021 dated 17.07.2021, Item No.656, under Div Jammu, Divisional Cadre posts, which was kept reserved.

It is further submitted that the document verification/ scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree and ascertaining genuineness/validity etc. or otherwise of the same and recognition status of the Institution, shall be responsibility of the Indenting Department/appointing authority.

It is further requested that in case any certificate/document, during the course of verification, turns out to be fake/fictitious, the Board may kindly be kept posted and appropriate criminal proceedings against such candidates may kindly be initiated.

These recommendations are subject to any ongoing inquiry and also outcome of writ petition(s), if any, pending before any competent Court of Law.

The other terms and conditions as conveyed vide letter No. JKSSB-Scry/18/2023-03 (E-7325184) dated 09.01.2024, shall remain the same. The instant communication may be cross verified from our website www.jkssb.nic.in.
