
Subject:- Selection of the candidates for the post of "Assistant Compiler"(Finance Department) Division Cadre, Kashmir in respect of advertisement vide Notification No.03 of 2020 dated 01-12-2020, item No.022, under Hon'ble Prime Minister Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits.

1) Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of of "Assistant Compiler"(Finance Department) Division Cadre, Kashmir in respect of advertisement vide Notification No.03 of 2020 dated 01-12-2020, item No.022, under Hon'ble Prime Minister Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits. and recommended the same to the intending department vide this Office letter No. SSB/Sel/Secy/M/03/2021/6314-20 Dated 23-09-2021 for further course of action; and

2) Whereas, the selection of the candidate namely **Anil Kumar S/O Bansi Lal Langoo R/O Ram Ghat Baramulla, figuring at S.No. 33/EWS** was kept withheld subject to certain clarification; and

3) Whereas, the provisional selection list of 300 candidates prepared for the post of Class-IV under items No.36,37,38,39,40,41,42,43,44 and 45 Advertised vide Notification No.03 of 2020 dated 01-12-2020, (Department of Disaster Management, Relief, Rehabilitation and Reconstruction) District Cadre Kashmir, under Hon'ble Prime Minister's Special Package for kashmiri Migrants and Non-Migrant Kashmiri Pandits was notified Vide No.SSB/Secy/Sel/2021/6917-26 Dated 09-10-21 in which the concerned candidates were informed to report within 07 days before the Board any sort of grievance; and

4) Whereas, the J&K Services Selection Board received a representation from the candidate namely **Anil Kumar** alongwith an affidavit mentioning therein that he is with drawing his candidature from the class-IV in the Revenue Department; and




5) Whereas, the representation of the candidate was examined by the Selection Committee and based on the report of Selection Committee was placed before the Board in its 191<sup>st</sup> Board meeting held on 18-10-2021, wherein it was decided to cancel the selection of the aforesaid candidate for Class-IV post and place him in the Assistant Complier selection list wherein a slot at S.No.33/EWS has been kept reserved for him because of his higher merit/preference; and

Now, therefore, in view of the above position, the withheld selection of **Anil Kumar S/O Bansi Lal Langoo R/O Ram Ghat Baramulla, figuring at S.No. 33/EWS** for the post of "Assistant Compiler"(Finance Department) Division Cadre, Kashmir in respect of advertisement vide Notification No.03 of 2020 dated 01-12-2020, item No.022, under Hon'ble Prime Minister Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits is hereby released. The merit position/particulars of the candidate is given at Annexure "A" to this order.

However, the other terms and conditions conveyed vide letter No. SSB/Sel/Secy/M/03/2021/6314-20 Dated 23-09-2021f, (selection list) shall remain the same.
