

The requisite documents have now been furnished by the said candidates and the case has been re-examined by the Board in its 198th Board meeting and accordingly, it was decided that the withheld recommendation of above said candidates shall be released.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27-09-2021, the candidate whose recommendation are released shall submit their verification rolls in triplicate before the appointing authority within a period of 21 days from its release, failing which the candidate shall forego his rights to appointment forthwith.

I am, therefore, directed to convey that the recommendation in favour of the above said candidates are hereby released as per terms and conditions already conveyed vide this office letter SSB/Secy/Sel/M/02/2021/6307-13 Dated 23-09-2021.
