Sir,

Kindly refer to this office letter No. JKSSB-SDOSECY(JMU)/2/2023-01 (E-7166430) dated 23.06.2023, regarding the subject cited above, where-under the Selection List for the post of Horticulture Technician Grade-IV in the Horticulture Department, advertised vide Notification No. 05 of 2021 dated 22.09.2021, under Item Nos. 690 to 709, was forwarded to your department for further course of action.

Among the selectees, the recommendations in respect of 60 candidates were kept withheld by the Board on account of various deficiencies. Out of these, 11 cases were released in 232<sup>nd</sup> Board Meeting and forwarded to your department. Subsequently, remaining withheld cases were deliberated in the Board, in its 264<sup>th</sup> meeting, which taking note of the documents received, decided to release another 11 withheld recommendations of the candidates selected as Horticulture Technician Grade-IV in the Horticulture Department, advertised vide Notification No. 05 of 2021 dated 22.09.2021, under Item Nos. 690 to 709.

Accordingly, the undersigned is directed to convey the above decision of the Board and release the withheld recommendation of the candidates as figuring in **Annexure-A** to this communication, with the request to proceed in the matter accordingly. The other terms and conditions as conveyed vide letter No. JKSSB-SDOSECY(JMU)/2/2023-01 (E-7166430) dated 23.06.2023, shall remain same.

The above recommendations shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction. The List shall also be subject to the outcome of any *inquiry*, involving candidate(s) figuring in this Selection List.




The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority.

The Selection of the candidates has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate/s may kindly be initiated.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates, whose recommendations are released by the Selection Agency, shall submit their Personal Verification Roll (PVR) before the appointing authority within a period of **21 days** from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
