Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) conducted OMR Based Written Examination for the posts of Assistant Law officer, Junior Legal Assistant, Reader and Legal Assistant, Various Cadres and various Advertisement Notification Nos, held on 20th of March, 2022, and,

Whereas, the JKSSB vide notice no SSB/COE/OMR/2022/2914-24 dated 20-03-2022 notified tentative answer key for viewing and seeking of representation/objections regarding correctness of the Questions/Answers from 21st of March 2022 to 24th of March 2022, for which link was activated on the official website of the JKSSB; and
