**Subject: Final Selection List for the posts of Junior Engineer (Civil), Public Works (R&B) Department, UT Cadre, advertised vide Notification No.06 of 2022 dated 11.11.2020, under Item No. 201 - Release of Revised Waiting List thereof.**

**NOTIFICATION**

Whereas, the J&K Services Selection Board (JKSSB) received an Indent from Public Works (R&B) Department for the posts of Junior Engineer (Civil) for making direct recruitment to these posts, as per following category-wise break up:

Whereas, the Final Selection List for these posts of Junior Engineer (Civil), was approved by the Board in the 261<sup>st</sup> meeting and, notified vide No. JKSSB-Scry/2/2024-03 (E-7390977) dated 21.02.2024. The waiting list for these posts was not drawn as such provisions were omitted; and

Whereas, vide S.O 134 dated 28<sup>th</sup> February, 2024, the provisions for preparation of the waiting lists were revived and under the provisions of S.O. 137 dated 28<sup>th</sup> February, 2024, the recruiting agencies, as a one-time exemption, have been permitted to draw up the wait list (s) in respect of those select list(s), which have been issued after 07.09.2023, within a period of six months; and

Whereas, the designated Selection Committee framed the Waiting List for these posts of Junior Engineer (Civil), which was subsequently approved in the 272<sup>nd</sup> Board Meeting and, notified vide No. JKSSB-Scry/2/2024-03 (E-7390977) dated 21.06.2024.

Whereas, after issuance of Waiting List, a representation was received from a candidate namely Mr. Nissar Ahmad Wani, wherein he has represented that his name is not reflected in the waiting list issued by the JKSSB for the post of JE Civil (PWD), even though he is possessing higher Marks (42.75) than last candidate selected under EWS category in the Waiting List; and

Whereas, the case was examined and it was observed that the candidate was not shortlisted under EWS due to oversight and his representation is based on merit. The case was placed in 278<sup>th</sup> Board Meeting held on 11.07.2024, which decided to undertake the Document Verification of the applicant; and

Whereas, on the basis of Board decision, the Document Verification Committee was constituted vide Order No. 263-SSB of 2024 dated 15.07.2024, and the candidate was called for DV on 16.07.2024. As the candidate was found eligible under EWS Category, the following position emerged:

Whereas, the Selection Committee, so constituted having regard to the merit of candidates prepared the Revised Waiting List in respect of these posts of Junior Engineer (Civil), under EWS Category; and

Whereas, the case was again placed in 293<sup>rd</sup> Board Meeting held on 23.12.2024, for reviewing its decision taken in the 278<sup>th</sup> Board Meeting to revise the waiting list for these posts of Junior Engineer (Civil), Public Works (R&B) Department, advertised vide Notification No. 06 of 2022, under Item No. 201 and instead consider revising the same to the extent of only change occurring under the EWS category on account of consideration of the candidature of Mr. Nissar Ahmed Wani; and


Whereas, on the basis of Board decision, the Document Verification Committee was constituted vide Order No. 263-SSB of 2024 dated 15.07.2024, and the candidate was called for DV on 16.07.2024; and


Whereas, on the basis of board decision, the Selection Committee, have been re-constituted vide Order No. 09-SSB of 2025 dated 08.01.2025, having regard to the merit of candidates prepared the Revised Waiting List in respect of these posts of Junior Engineer (Civil), under EWS Category.

Now therefore, after taking into consideration all the aforementioned factors, the **Revised Waiting List** under EWS Category to the extent of aforementioned candidates for the posts of Junior Engineer (Civil), Public Works (R&B) Department, advertised Vide Notification No. 06 of 2022 dated: 11.11.2022, is hereby notified in respect of eligible candidates as **per Annexure-A** to this Notification: It is further ordered that:

- i. The Revised Waiting List shall be subject to outcome of writ petition(s)/OA(s), if any, pending in the court of law.
- ii. This list shall also be subject to the outcome of any pending enquiry, involving candidate(s), figuring in the Selection/Waiting List.
- iii. Formal recommendations to the concerned indenting department shall be made separately.
- iv. The candidate(s) whose recommendation is kept withheld shall submit the requisite documents/certificates within a period of one month.
- v. The Selection of the candidates has been made on the basis of self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection in the list on the basis of false documents/certificates, the selection shall be liable to cancellation at any stage.
