Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of "Accounts Assistant" (Panchayat)" (Department of Rural Development and Panchayati Raj), advertisement vide Notification No.02 of 2020 dated 06-07-2020 under Items No.01 to 20 for all Districts of J&K Union Territory and recommended the same to the Intending Department vide this Office letter No. SSB/Secy/Sel/2021/4866-72 Dated 08-07-2021 for further course of action; and

Whereas, the selection of the candidate namely **Bikram Singh S/O Pawan Singh figuring at S.No. 51/OM/ALC District Kathua** was kept withheld subject to production of valid ALC/IB certificate from the competent authority; and

Whereas, subsequently through a representation the candidate has submitted to consider his candidature under OM Category; and

Whereas, the case of the candidate was placed before the Board in its 194th Board meeting wherein it was decided to consider the candidature of the above said candidate under open merit instead of ALC/IB category as per his merit; and

Whereas, it has been found that the candidate on the basis of an his merit in the written examination and other condition laid down for the post of "Accounts Assistant" (Panchayat)" was figuring in the OM category and his selection to the post shall remain unchanged, even if his candidature under ALC/IB is withdrawn and modify it was, therefore, decided that his withheld recommendation be released as an open merit (OM) category candidate.

Now, therefore, in light of the background so narrated here in above the withheld recommendation of the namely **Bikram Singh S/O Pawan Singh figuring at S.No. 51/OM District Kathua** for the post of "Accounts Assistant" (Panchayat)" (Department of Rural Development and Panchayati Raj), advertised vide Notification No.02 of 2020 dated 06-07-2020 under Items No.01 to 20 for all Districts of J&K Union Territory is hereby released.
