**Subject: - Withdrawal of posts of Sericulture Assistant, Seed Examiner and Field Assistant requisitioned by the Department of Agriculture Production and Farmer's Welfare, advertised vide Advertisement Notification No. 05 of 2021 Dated: 09-10-2021.**


Whereas, the Agriculture Production and Farmer's Welfare Department vide Indent Agri/Cord/25/2020/357 dated 01.10.2020 followed by No. Agri/Cord/06/2021/363 dated 23.08.2021 referred/requisitioned 101 posts of various Categories including 17 posts of Sericulture Assistant, 23 posts of Seed Examiner and 23 posts of Field Assistant; and


