Sub:- Cancellation of candidature of candidates Selected for the post of **"Accounts Assistant"** (Finance Department) Divisional Cadre Kashmir, advertised vide Advertisement Notice No. 01 of 2012 dated 19.07.2012 at item No. 053 under Hon'ble Prime Minister's Special package for Kashmiri Migrants.

Whereas, the J&K Services Selection Board notified the selection list of the candidate for the post **"Accounts Assistant"** (Finance Department) Divisional Cadre Kashmir, advertised vide Advertisement Notice No. 01 of 2012 dated 19.07.2012 at item No. 053 under Hon'ble Prime Minister's Special package for Kashmiri Migrants and forwarded the same to the indenting department vide this office letter No. SSB/Secy/Sel/2015/3603-08 dated 31.03.2015 for further course of action; and

Whereas, the Board while preparing the selection list for the above said post, kept two slots blank at S.No. 20 and 43 under open merit category respectively for want of certain clarification; and


Whereas, from perusal of the record file, it has been found that two candidates namely **Santosh Kumar** and **Vineet Bhat** are existing at S.No.20/OM and 43/OM respectively which have been kept blank for want of clarification; and

Whereas, from perusal of the documents submitted by these candidates, it has been found that the candidate namely Santosh Kumar has passed B.Sc (IT) from Punjab Technical University vide admission dated 2005 through Study Centre having address as 168-A Opposite Government Quarters, bear Shiv Mandir, Jammu for which the candidate has also submitted bonafide certificate issued by Assistant Registrar, Directorate of Distance Education vide No. PTU/DDE/11482 dated 09.01.2015. Similarly, from perusal of the documents submitted by another candidate namely Vineet Bhat, it has been found that the candidate has passed his Graduation in distance mode from Makhan Lal Chaturvedi, Bhopal through Study Centre viz Kawa Institute of Management and Technology Jammu w.e.f. 2006 to 2008.



Whereas, the case was placed before the Board in its 194th Board meeting wherein it was decided that after extensive discussion on all relevant aspects, the Board decided to declare both the candidates as "**NOT ELIGIBLE**", in terms of Government order No. 252-HE of 2012 dated 30.05.2012.

Now, therefore, in view of the above position, the withheld selection of the above two candidate namely **Santosh Kumar** and **Vineet Bhat** figuring at S.No.20/OM and 43/OM respectively for the post of "**Accounts Assistant**" (Finance Department) Divisional Cadre Kashmir, advertised vide Advertisement Notice No. 01 of 2012 dated 19.07.2012 at item No. 053 under Hon'ble Prime Minister's Special package for Kashmiri Migrants are hereby cancelled abinitio. The Indenting Department may proceed further in the matter in accordance with extant rules.
