1/ Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) notified final select list of the candidates for the post of "Accounts Assistant" Divisional Cadre Kashmir pursuant to Advertisement Notification No.01 of 2012 dated 19.07.2012, item No. 053 under Hon'ble Prime Minister's special package for Kashmiri migrants and recommended the same to the indenting Department vide letter No. SSB/Sel/Secy/2015/3603-08 dated 31.03.2015 for further course of action; and



5/ Now, therefore, in the view of the facts and circumstances narrated herein above, the candidature of the candidates namely Shabeena Nisar D/o Aijaz Ahmad, Sandeep Koul S/o Chaman Lal Koul and Nitish Bhan S/o N K Bhan figuring at S.No. 10/OM/Waiting, 11/OM/Waiting, 14/OM/Waiting respectively for the post of "Accounts Assistant" Divisional Cadre Kashmir pursuant to Advertisement Notification No.01 of 2012 dated 19.07.2012, item No. 053 under Hon'ble Prime Minister's Special Package for Kashmiri Migrants is hereby cancelled/ withdrawn ab-initio and the indenting department is requested to operate the waiting list, if required in accordance with extant norms.
