Subject: Submission of Offline application forms for Appellants in light of order dated 17.12.2021 passed by Hon'ble Central Administrative Tribunal in O.A./1855/2021 with M.A. 1973/2021 titled Vikram Kumar & others v/s Union Territory of J&K & others.

Whereas, the Home Department vide indent No. Home /PB-III/ 34 /2021 dated 02.07.2021 requisitioned/referred, 800 posts of Sub-Inspector;

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) vide Advertisement Notification No. 06 of 2021 dated 21.10.2021, invited online applications from eligible candidates for participating in the selection process for aforesaid 800 Posts of Sub-Inspectors; and

Whereas, the requirement of age for Open Merit & various Reserved Categories candidates as notified in the aforesaid Advertisement Notification in terms of rule 176(1) (c) of S.O 214, dated 01-07-2021 and S.O 361 dated 20-10 -2021 is as under:

"A candidate must have attained age of 18 years but not crossed the age of 28 years on 1st January of the year in which notification inviting applications is issued by the Jammu and Kashmir Services Selection Board",and;

Whereas, the Home Department vide letter dated 23.11.2021 conveyed to increase the number of posts of Sub-Inspectors by 400, viz, from 800 to 1200, and subsequently, vide Notification No. SSB/Secy/2021/7926-42 dated 24.11.2021 JKSSB increased the number of posts from 800 to 1200, and;

Whereas, the date of commencement for submission of online applications was 10-11-2021 and the last Date for submission of online applications was fixed as 10-12-2021; and

Whereas, the last date for submission of online applications for aforesaid posts advertised vide Advertisement Notification No. 06 of 2021 dated 21.10.2021 was extended upto 18-12-2021 vide Notice No. SSB/Secy/2021/8547-64 dated 08.12.2021; and,

Whereas, the Home Department vide S.O notification No.420 dated 10-12-2021 has prescribed upper age limit for Open Merit & various Reserved Categories candidates as 30 years and 32 years in respect of the in-service Police Personnel, as on 1st January,2021.

Whereas, the Jammu and Kashmir Services Selection Board issued corrigendum notification vide No.SSB/Secy/2021/8628-44 dated:-10-12-2021 wherein Maximum Age Limit for Open Merit & various Reserved Categories candidates has been prescribed as 30 years and 32 years in respect of the in-service Police Personnel, as on 1st January,2021.

Whereas, 37 candidates approached the Hon'ble Central Administrative Tribunal with the plea to direct respondents to prescribe upper age limit as 33 years for recruitment to the post of Sub-Inspectors, advertised by J&K services Selection Board Vide Advertisement Notification No. 06 of 2021 dated 21.10.2021; and,

Whereas, the Hon'ble Central Administrative Tribunal vide order dated 17/12/2021 in O.A./1855/2021 with M.A. 1973/2021 titled Vikram Kumar & others v/s Union Territory of J&K & others, was pleased to pass order as under

"...Meanwhile the application forms of the applicants be accepted provided the last date for accepting the forms, as per submission of the learned counsel for the applicants, is 18.12.2021 and thereafter, the applicants to be permitted to participate in the selection process at their own cost and risk. However, the result of the applicants shall not be declared till further orders from the Tribunal..."


Whereas, the matter has been examined by the Board in deference to the aforesaid orders of the Hon'ble Central Administrative Tribunal and it has been decided to accept Offline Forms from 37 Appellants as referred in O.A./1855/2021 with M.A. 1973/2021 titled Vikram Kumar & others v/s Union Territory of J&K & others;

Now, therefore, in the light of above, the Appellants as referred in O.A./1855/2021 with M.A. 1973/2021 titled Vikram Kumar & others v/s Union Territory of J&K & others and figuring in **Annexure "A"** to this notification, are allowed and directed to submit the application form on the prescribed Application Form annexed herewith as Annexure "B" along with requisite fees (Fee payable: Rs.550/- except for candidates belonging to SC/ST Category for which fee payable is Rs.400/-) in the form of Bank Draft favouring Secretary J&K Services Selection Board, payable at J&K Bank, Poloview Srinagar, for the posts advertised vide Advertisement Notification No. 06 of 2021 dated 21.10.2021 **by or before 31-12-2021** in the Central Office of JKSSB, Hema Complex, Sector -3, Channi

Himmat, Jammu/ JKSSB, Camp office, Zamzam Complex Rambagh Srinagar, at their own risk and responsibility and their candidature is provisional subject to further directions from the Hon'ble Tribunal, and fulfilment of conditions laid down in relevant rules.

Other terms and conditions as laid down in the afore said notification shall remain unchanged.
