Subject:- Selection list of the candidates under SRO-202 for the post of "Jr. Staff Nurse," (Health and Medical Education Department) Divisional Cadre Jammu (GMC Doda) vide Advertisement notice No. 08 of 2019 under item No.003, withheld recommendation release thereof.

Sir,

Kindly refer to this office communication No. SSB/Secy/Sel/J/76/2020/2552-58 dated 02-04-2020, regarding the subject cited above, vide which the select list of Candidate for the post of "Jr. Staff Nurse," (Health and Medical Education Department) Divisional Cadre Jammu (GMC Doda) vide Advertisement notice No. 08 of 2019 under item No.003, was forwarded to your department for further course of action.

Out of the said list ,the recommendation of the **one (01) candidate namely Shashi Devi figuring at S.No.16/Wait/OM/** was kept withheld for want of some clarification in respect of her documents. The case was re-examined by the Board in its 202nd Board meeting held on 13-05-2022 and it was decided that the withheld recommendation of the above said candidate shall be released. Meanwhile, the General Administration vide No. GAD-MTGORBIV/200/2021-09-GAD Dated 03-02-2022 has forwarded the Administrative Council Decision No.01-01-2022 dated 29-01-2022 which is reproduced as under:

"All posts referred to JKPSB/JKSSB prior to 31.10.2019, which selection have not been Finalized till date, as also the posts in which there are litigation and the cases are pending in Hon'ble Courts, shall be deemed to have been withdrawn with immediate effect,"

Accordingly, vide this office communication No. SSB/Secy/Sel/03/21/UT/381-82 dated 18.02.2022, the matter was taken up with the General Administration Department with the request to clarify whether the recommendation of candidates which have been kept withheld for one or other reasons can be released by the Board for such posts for which selection list have already been finalized/forwarded to the Indenting Department before the issuance of above said communication.

The General Administration Department subsequently vide communication No. GAD-MtgORBIV/35/2022-09-GAD dated 03.03.2022 also requested to furnish the details of all such posts referred prior to 31.10.2019 and still not returned to indenting departments in pursuance of the recent Administrative Council Decision, thereby incorporating the reasons for same specially with respect to the posts for which recommendations have been kept withheld. Besides, number of posts for which recommendations, if any are still pending after the declaration of result.

Accordingly, vide this office communication No. SSB/Adm/09/2022/3531-32 dated 31.03.2022, the information was forwarded to the General Administration Department with the request that it would be fit and appropriate to treat cases of withheld recommendations to be outside the scope and ambit of instructions conveyed vide aforementioned communication.

In response to the aforementioned communication, the General Administration vide letter No. GAD-MTGORBIV/35/2022-09-GAD dated 12-04-2022 has intimated to conclude the process of release of withheld recommendation/appointment, subject to the following conditions: -


1. The post (s) is free from all encumbrances, and the J&K Services Selection Board has approved the release of recommendation in favour of these candidates (s) after satisfying itself of the eligibility conditions, educational qualification possessed by the candidates, verification of reserved category certificates, verification of migrant status, residency/domicile certificates etc. as applicable.
2. that there are no interventions of Hon'ble Courts/Central Administrative Tribunal at present.
3. All other terms and conditions for release of recommendations, appointment orders issued by the from time to time are followed.

I am, therefore, directed to convey that the recommendation in favour of the above said candidate is hereby released as per terms and conditions already conveyed vide this office letter SSB/Secy/Sel/J/76/2020/2552-58 dated 02-04-2020. The instant communication may be cross verified from our website www.jkssb.nic.in.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27-09-2021, the candidate whose recommendation are released shall submit their verification rolls in triplicate before the appointing authority within a period of 21 days from its release, falling which the candidate shall forego his rights to appointment forthwith.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of category/degree certificate with reference to the advertisement notification and establishing the genuineness and validity or otherwise of the same shall be responsibility of the appointing authority.

Subject:- Cancellation of selection of the candidate for the post of "Technical Assistant" (Health and Medical Education Department), Divisional Cadre Jammu (GMC Kathua) vide item No.014 (05 of 2019).

1) Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of **"Technical Assistant" (Health and Medical Education Department), Divisional Cadre Jammu (GMC Kathua) vide item No.014 (05 of 2019)** and recommended the same to the intending department vide this Office letter No. SSB/Secy/Sel/J/65/2020/2134-40 dated 12-03-2020 for further course of action; and

2) Whereas, the selection of the candidate namely Yaser Chauhan S/O Abdul Majid R/O Lamberi, Nowshera Rajouri figuring at S.No.01/ST was kept withheld, subject to validity and verification of diploma Anaesthesia and verification of 12th class.; and

3) Whereas, the aforesaid candidate has submitted the Diploma certificate in Anaesthesia Assistant issued by the Director Saraswati College of Education, H.NO. 3423 under Roll NO.JK/0360/AA/16 ; and


4) Whereas, the Service Selection Board took up the matter with the Registrar, J&K State Para Medical Council, Jammu vide No.SSB/Sel/Verif/52/20/J/4089 Dated 08-11-2020 regarding validity of Diploma certificate of Anesthesia. In response, a communication was received from the concerned vide No.JKPMC-19-20/63/7628 Dated 09-10-2021, which reveals that the "The council of Technical Education and Training in its reply has clarified that the Diploma in Anesthesia Assistant in the name of Yaser Chauhan is not issued by their office"; and

5) Whereas, the case of the candidate was placed in the 202nd Board meeting of the Services Selection Board and it was decided to cancel the selection of the candidate in light of clarification received from the J&K Para Medical Council, Jammu.




Now, therefore, in view of the above position, the withheld selection of the candidate namely **Yaser Chauhan S/O Abdul Majid R/O Lamberi, Nowshera Rajouri** figuring at **S.No.01/ST** for the post of "Technical Assistant" (Health and Medical Education Department), Divisional Cadre Jammu (GMC Kathua) vide item No.014 (05 of 2019) is hereby cancelled abinitio. The indenting department may operate the waiting list, if required, in accordance with extant rules.
