Consequent upon the indent/requisition furnished by the Health & Medical Education Department vide No. HD/NG/232/2015 dated 23.09.2015 for the post of **Jr. Assistant**, District Cadre Pulwama and the advertisement notification in respect of said posts was issued by the Board vide Notification No 07 of 2015 dated 02.12.2015 under Item No. 690, with the category wise break-up of the posts is as under:

On the basis of merit obtained in the Type Test, CBT exam and viva voce by the candidates for the post of **Junior Assistants** in Health & Medical Education Department District Cadre Pulwama, a selection list of 03 candidates under OM category along with waiting list of 03 candidates under OM category has been framed and placed before the Board on 23.04.2021 in its 182nd Board meeting. After the threadbare discussion it has been decided by the Board to release the selection list of 03 candidates under OM category alongwith waiting list of 03 candidates. In respect of RBA category, the selection of 01 candidate was approved by the Board in its 186th Board meeting held on 26th & 27th August 2021

However, 02 posts (SC=01 & ST=01) remained unfilled due to non availability of eligible candidates under the said categories and accordingly returned to the indenting department.

Further, the list notified shall be subject to the outcome of writ petition (s) (if any) pending disposal before any competent Court of jurisdiction related to the selection.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of category/degree genuineness/ validity


or otherwise of the same shall be responsibility of the indenting Department/appointing authority.

Order No. 1003-JK (GAD) of 2021 dated 27.09.2021, the candidates whose recommendations are released shall submit their verification rolls in triplicate before the appointing authority within a period of 21 days from its release, failing which the candidates shall forego their right to appointment forthwith.

You are further requested that in case any certificate/document, during the course of verification, turns out to be fake/fictitious, the Board may kindly be kept posted and appropriate criminal proceeding against such candidates may please be initiated.


