Since the combined CBT was held for the post of **Junior Assistants** for
Education, Revenue and Cooperative Department. Combined selection list was
prepared and preference of the Departments was sought from the selected
candidates vide this office Notice No. SSB/SECY/SEL/2021/4319-29 dated
08.06.2021 and the selected candidates have submitted their preferences. On the
basis of preferences given by the selected candidates, a selection list of 01
candidate under OM category is hereby forwarded as Annexure "A".

However, 01 post under RBA category remained unfilled due to non
availability of eligible candidate under the said category and accordingly returned
to the indenting department.


Further, the list notified shall be subject to the outcome of writ petition (s) (if any) pending disposal before any competent Court of jurisdiction related to the selection.
