Consequent upon the receipt of indent/requisition furnished by the Revenue Department vide No. Rev/NG/15/2011 dated 27.04.2011 for the post of Junior Assistants District cadre Reasi, the advertisement notification in respect of said posts was issued by the Board vide Notification No 04 of 2015 dated 10.08.2015 under Item No. 151 including posts of Cooperative & Education Department with the category wise break-up of the posts (**as backlog vacancies**) as under:

The Board conducted the laid down examination/skill tests in accordance with the prescribed norms and procedures and finalized the selection process. Subsequently, the combined selection list was prepared in light of the criteria adopted by the Board under relevant rules and on the basis of merit obtained by the candidates, combined selection lists was approved by the Board and uploaded on the official website of JKSSB.

Since the combined CBT was held for the post of **Junior Assistants** for Education, Revenue and Cooperative Department. Combined selection list was prepared and preference of the Departments was sought from the selected candidates vide this office Notice No. SSB/SECY/SEL/2021/4319-29 dated 08.06.2021 and the selected candidates have submitted their preferences. On the basis of preferences given by the selected candidates, a selection list of 02 candidates, 01 under OM category and 01 under RBA category is hereby forwarded as Annexure "A".

However, 02 posts (ST=01 & OSC=01) remained unfilled due to non availability of eligible candidates under the said categories and accordingly returned to the indenting department.


Further, the list notified shall be subject to the outcome of writ petition (s) (if any) pending disposal before any competent Court of jurisdiction related to the selection.
