ORDER NO. 41 -SSB of 2022

DATED: 07 -02-2022

Subject: - O.A.61/1165/2021 titled Yasir Hussain Kripak Vs UT of J&K & Ors.

1. Whereas, the Jammu and Kashmir Services Selection Board advertised various posts including the post of Driver, GMC Doda, Divisional cadre Jammu, Health and Medical Education department in pursuant to Advertisement Notification No. 04 of 2019 dated 01.02.2019 under Item No. 40 with the following break up:

OM=06, RBA=03, SC=01, ST=01, ALC=01 Total=12

2. Whereas, the prescribed qualification for the aforesaid post is as under:-
“Minimum Matric and Maximum 10+2 with valid HMV License”.
3. Whereas, the Jammu and Kashmir Services Selection Board after completion of the selection process for the aforesaid posts, issued the Selection List and forwarded the same to the Indenting Department (Health and Medical Education Department) vide communication No. SSB/Secy/Sel/J/80/2020/3086-92 dated 08.05.2020.
4.  Whereas, the candidate/Applicant namely Yasir Hussain Kripak S/o Fiaz Mohd Kripak, R/o Village Arnora Ghat, Tehsil and District, Doda figured at serial no. 06/OM but his recommendation was kept withheld for want of clarification with regard to requisite qualification.
5. Whereas, feeling aggrieved of his withheld recommendation, the applicant has filed an OA bearing OA No. 61/1165/2021 titled Yasir Hussain Kripak V/s UT of J&K and others before the Hon'ble Central Administrative Tribunal Jammu and the Hon'ble Tribunal vide its order dated 09.08.2021 disposed of the said OA with the following directions:-

“In view of the submissions made by the learned counsel for the applicant, the O.A. is disposed of at the admission stage with a direction to the respondents to consider and decided the representation of the applicant dated 22.07.2020 in accordance with rules by passing a reasoned and speaking order within a period of two


months from the date of receipt of certified copy of this order. The order so passed shall be communicated to the applicant forthwith”.


6. Whereas, in pursuance of the aforesaid directions of the Hon'ble Central Administrative Tribunal (CAT), the case was examined by the Sub-Committee and during verification it has been found that the petitioner is a Graduate as per the documents submitted by him for seeking release of withheld recommendation, as such holds qualification higher than required as per the qualification prescribed in the requisition/Advertisement Notification and accordingly recommended to declare the candidate as Not Eligible. And

7. Whereas, subsequently, the matter was placed before the J&K Services Selection Board in its 197th Board meeting held on 25.01.2022 in compliance with the directions of the Hon'ble Tribunal, Jammu and as per recruitment rules in vogue, and it was decided to reject the claim of the Applicant by way of issuing a speaking order in this regard; and

Now, therefore, in deference to the order dated 09.08.2021 passed by the Hon'ble Central Administrative Tribunal, Jammu in OA No. 61/1165/2021 titled Yasir Hussain Kripak v/s UT of J&K & Others, and as per the decision of the Board, the Candidature of the petitioner namely Yasir Hussain Kripak S/o Fiaz Mohd Kraipak R/o Village Arnora Ghat, Tehsil and District Doda has been considered for the Post of Driver, GMC Doda, Divisional cadre Jammu in pursuance to Advertisement Notification No. 04 of 2019 dated 01.02.2019 under Item No. 40, and rejected, being without any merit.
