Kindly refer to this office letter No. JKSSB-SD0SECY(UT)/1/2023-01(E-7099079) dated 25.01.2024, where-under the Selection List of candidates for various ITI posts viz; Junior Electrician, Divisional Cadre, Kashmir, Item No. 237, Xerox Assistant, Divisional Cadre, Kashmir, Item No. 219 and Junior Electrician, Divisional Cadre, Jammu, Item No. 192, of H&ME Department, pursuant to Advertisement Notification No. 02 of 2021 dated 26.03.2021, was forwarded to your department for further course of action.

Among the selectees, the recommendation of the following candidates was kept withheld:

1. Mr. Jahangir Ahmad Shah Faqeer (01/RBA), Junior Electrician (Item No. 237).
2. Mr. Umair Nazir Wani (01/OM), X-Ray Assistant (Item No. 219).
3. Mr. Intiyaz Ahmad Bhat (01/RBA), Junior Electrician (Item No. 192).

The above candidates have submitted the requisite documents, along-with an affidavit duly authenticated by 1st Class Magistrate (copies enclosed). These documents were placed in the Board, which after due deliberations, decided to release the withheld recommendations of these candidates, *with the condition that the appointing authority shall satisfy itself on account of higher qualification possessed by these candidates before issuing appointment order.*

Accordingly, the undersigned is directed to convey the above decision of the Board and release the withheld recommendations of the aforesaid candidates. Since the Board has considered these candidates for selection as per the documents submitted by

them and accepted their minimum and maximum qualification for these posts as per their self-declaration/affidavits, the appointing authority shall verify the maximum qualification possessed by the aforementioned candidates before issuing their appointment orders.

Further, the document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority. As the Selection of the candidates has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate/s may kindly be initiated.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates, whose recommendations are released by the Selection Agency, shall submit their Personal Verification Roll (PVR) before the appointing authority within a period of 21 days from its release, failing which the candidate(s) shall forego their right to appointment forthwith.

The other terms and conditions as conveyed vide letter this office letter No. JKSSB-SD0SECY(UT)/1/2023-01(E-7099079) dated 27.06.2023, shall remain the same.
