**WHEREAS**, the case of the candidate was placed in the 177<sup>th</sup> Board meeting and the Board declare the above-named candidate as NOT Eligible, as the PRC had been issued after cut of date; and

**WHEREAS**, the aforesaid candidate approached the Board through a medium representation whereunder she has submitted that PRC of her husband, which was not furnished submitted earlier by her. The said PRC has been issued vide No. 1584/SA dated 03.12.1994, issued under the seal and signature of Additional Deputy Commissioner, Jammu and she had got married on 04.12.2008; and


**WHEREAS**, the case of the candidate was placed in the 182<sup>nd</sup> Board and meeting after due consideration, it was decided to revisit the matter and release



the withheld recommendation/selection in favour of the candidate namely Sulakshna Bhat.

Now, therefore, in view of the above position, the withheld recommendation of **Sulakshna Bhat, figuring at S.No. 53/OM for the post of "Junior Statistical Assistant"** Planning and Development Department (Hon'ble Prime Minister's Special Package), item No. 154 (04 of 2017) Divisional Cadre Kashmir is hereby released with immediate effect.
