Whereas, the selection of the candidate namely Sapna Sudan D/O Late Ashok Kumar Sudan R/O Block No. 145 Flat No. 2 Nagrota Jagti Jammu figuring at S. No. 01/SC was kept withheld subject to production of valid SC category certificate.

Whereas, the candidate has submitted an affidavit duly attested by the Sub Judge, Judicial Magistrate 1st Class, Jammu on 30th of June 2020, which reveals that the aforesaid candidate inadvertently applied under the category of Scheduled Caste while the fact is that she belongs to Backward Class and;

Whereas, the case of the candidate's was placed in the 175th Board Meeting wherein it was found that her claim is not genuine and supported by an valid proof of having requisite category certificate at relevant date.

Whereas, the Board vide Order No. 331-SSB of 2020 dated 14.12.2020 cancelled the selection in favour of Sapna Sudan D/O Late Ashok Kumar R/O Block No. 145 Flat No.2 Nagrota Jagti Jammu figuring at S. No. 01/SC for the post of Village Level Worker (Rural Development & Panchayati Raj Department) District Cadre Baramulla, in pursuance to the advertisement Notification No. 04 of 2017 dated 28.11.2017, Item No. 75 and;

Whereas, that one candidate namely Bharti Pandita who is figuring at S. No. 01/Waiting submitted a representation to Secretary, J&K Services Selection Board on 22.12.2020 and requested that the posts of SC category may kindly be got de-reserved in terms of Government Order 10-DMRRR of 2019 dated 06.03.2019 and;

Whereas, accordingly the case of the candidate was placed in the Board in its 178th Meeting wherein it was decided to de-reserve one post of SC category to open category, pursuant to Government Order No.10-DMRRR of 2019 dated: 06-03 2019.

Now, therefore keeping in view of the above facts and pursuant to Government Order 10-DMRRR of 2019 dated 06.03.2019 one post of SC category has been dereserved and accordingly selection list has been re-casted. After partly recasting of the selection list putting the candidate namely Bharti Pandita who was selected under waiting list at Sr. No. (01) has been placed in the OM category at Sr. No.06 and the selection list is enclosed as Annexure-A under Item No.075 (04 of 2017), "Village Level Worker" under PM's Special Package Department of Disaster Management, Relief, Rehabilitation & Reconstruction, District Cadre Baramulla.
