Consequent upon the receipt of Indent/requisition from the Transport Department, vide No. TR-09/SMG/2015 dated 03.12.2020, for the 18 posts of Motor Vehicle Traffic Assistant under UT Cadre & Divisional Cadre Kashmir/Jammu, the Advertisement Notification in respect of the said posts was issued by the Board vide No. 04 of 2020 dated 16.12.2020, under Item Nos. 087, 091 & 095, with the category-wise breakup of posts as under:

As per the requisite qualification conveyed by the Indenting Department and the criteria adopted by the Jammu and Kashmir Services Selection Board, the Computer Based Test (CBT) for these



posts was held and on the basis of the performance of the candidates, the result/Score sheet was notified vide Notification No.SSB/COE/CBT/2022/2718-24 dated 15.03.2022. The candidates falling under consideration zone were called for Document Verification and the Board sought preferences from the candidates figuring in the consideration zone vide Notification No. SSB/COE/CBT/2022/4597-4603 dated 30.05.2022, in order to avoid the repetition of the candidates.

The Provisional Selection Lists, along-with the Waiting Lists, for these posts of Motor Vehicle Traffic Assistant, for UT Cadre, Divisional Cadre Kashmir/Jammu, advertised under Item No. 087, 091 & 095, were notified vide Notification No. SSB/Secy/Sel/2022/5074-83 dated 01.07.2022 and objections were sought from the candidates.

Subsequently, the Final Selection Lists were approved by the Board in its 207<sup>th</sup> Meeting held on 29.07.2022 and the same were notified vide SSB/Secy/2022/5630-40 dated 02.08.2022.
