**Whereas**, the Jammu and Kashmir Services Selection Board (JK SSB) advertised aforesaid 19 UT cadre posts of Laboratory Assistant in Home Department vide Advertisement Notification No. 06 of 2020, under Item No. 231 and last date for submission of online applications was 31.01.2021; and

**Whereas**, the Jammu and Kashmir Services Selection Board (JKSSB) conducted CBT examination for the various posts including the aforementioned posts of Laboratory Assistant w.e.f. 08.11.2021 to 12.11.2021. The tentative answer key(s) were notified vide Notice No. SSB/COE/CBT/2021/7626-33 dated 12.11.2021 for seeking Objections, subsequently a revised answer key was also issued vide No. SSB/CoE/2021/8506-13 dated 07.12.2021; and

**Whereas**, vide order No. 35-SSB of 2022 dated 04.02.2022 the committee was constituted for conducting of documents verification for the post of Laboratory Assistant w.e.f.07.02.2022 to 12.02.2022 in which 82 (45J+37K) Nos. of candidates called for D.V, out of which 68 candidates (37J+31K) appeared in DV and 14 (08J+06K) candidates were absent, thereafter left out candidates were also again called for DV vide No.SSB/CoE/CBT/2022/3950-55 dated 21.04.2022 in which only 02 candidates of Jammu Division submitted their documents before the committee. Hence, total No. of 70 candidates appeared in both DVs and 12 candidates were absent out of 82; and

**Whereas**, vide order No.220-SSB of 2022 dated 01.07.2022 the selection committee for the aforementioned post was constituted for making recommendations for the aforesaid posts; and

**Whereas**, the selection committee so constituted has examined case to case basis of documents submitted by the candidates before the documents verification committees, merits obtained by the candidates in the CBT examination and prepared provisional selection list as per below mentioned vacancy chart:

**Whereas,** based on the above, a Provisional Selection list of 19 candidates along with the waiting list of 11 candidates was prepared by the Selection Committee and was placed before the Board in its 205<sup>th</sup> Board meeting held on 13.07.2022 along with the application forms and other relevant documents of the candidates and the Board decided to release the provisional Selection list of 19 candidates along with the waiting list of 11 candidates for the post of **Laboratory Assistant of Home Department**; and

**Whereas,** the Board after threadbare discussions approved the provisional selection list and accordingly a notification to this effect was issued vide No: SSB/Secy/Sel/2022/5267-73 dated: 15-07-2022.

**Whereas,** it was also notified that the candidates, if have any grievance with regard to the provisional selection list may furnish their representations/objection through email **id ssbjkgrievance@gmail.com** within 5 days; and

**Whereas,** the JKSSB received 06 Nos. of representations from the candidates who are aggrieved of the provisional selection list. The claim of the applicants /petitioner was placed before the Board in its 207<sup>th</sup> Board meeting held on 29.07.2022 and after holding detailed deliberations/discussions the Board decided to reject the claims of the applicants/petitioner as the same are devoid of merit; and

**Whereas,** the Hon'ble Central Administrative Tribunal (CAT) Srinagar Bench, in the case titled Tawheed Ahmad Rather S/o Ghulam Ahmad Rather bearing O.A. No. 674 dated 18.07.2022 has issued directions for consideration of the claim of the applicant, that has been examined separately; and



**Whereas**, the Board in its aforementioned meeting, decided to issue the Selection List.

Now, therefore, in view the above:

1. The Selection List alongwith the waiting list of the candidates for the post of Laboratory Assistant, Home Department advertisement vide Notification No. 06 of 2020 dated 29.12.2020, under Item No. 231 is enclosed as **Annexure-"A"** to the notification.
2. The selection list shall be subject to the outcome of any writ petition(s), pending in any court of law of the competent jurisdiction.
