
Whereas, among the selectees, the recommendation of **two candidates** namely **Mr. Akhil Kotwal**, S/o Reshi Kumar, R/o 1, Kandosu, Choundary, Bhalla, Doda, 182201 figuring at **Sr. No. 03/OM category** under **Item No. 676 Advertisement Notification No. 04 of 2021 dated 17.07.2021**, was kept withheld subject to production of all original documents and **Mr. Ashish Sharma**, S/o T R Sharma, R/o Village Bhakna, Mohalla Bhakna, 0, Mohalla, Doda, 182202, figuring at **Sr. No. 01/EWS category** under **Item No. 134, Advertisement Notification No. 04 of 2022 dated 27.07.2022**, was kept withheld subject to production of valid within date EWS certificate, as per format; and

Whereas, through medium of notice dated 19.03.2025, the above mentioned candidates were afforded a final opportunity to submit the requisite documents/certificates to fulfill the deficiencies.

Whereas, the above mentioned candidates failed to produce


the requisite documents and accordingly the withheld recommendation cases were placed in the 302nd Board Meeting, wherein the Board took note of the fact that despite sufficient time/opportunities afforded to the candidates, the candidates have failed to produce the requisite documents/clarifications as asked for in the matter and, accordingly decided to cancel their withheld recommendations.
