Consequent upon the receipt of requisition from the Transport Department, vide Indent No.TRPT-SMG0N/20/2021-02-TPT dated 12.04.2022, the Jammu and Kashmir Services Selection Board (JKSSB), advertised **17 posts** of Driver-II, UT Cadre vide Notification No.04 of 2022 dated 27.07.2022, with the category-wise breakup of posts as under:

The JKSSB conducted the Driving Test for these posts, which was followed by the Written Examination (OMR based) on 24.12.2023, and, thereafter, on the basis of merit obtained by the candidates, the Document Verification was conducted.

After seeking preferences from the candidates and on the basis of the principle of *Merit-cum-Preference*, the Final Selection List was approved by the Board and subsequently notified vide Notification No.20-Selection of 2024 dated 22.05.2024.

Accordingly, the undersigned is directed to forward herewith the selection list of **17 posts** of "Driver-II" Transport Department, UT Cadre, advertised vide Notification No. 04 of 2022 dated 27.07.2022 under Item No. 121 as per **Annexure- E** to this communication.

The appointing authority shall satisfy itself on account of this before issuing the appointment order and, if at any stage, it comes to the notice that they are in possession of qualification other than the required for the post and they have willfully submitted wrong information, the necessary action as per rules may be taken, under an intimation to the J&K Services Selection Board".

It is further requested that in case any certificate/document, during the course of verification, turns out to be fake/fictitious, appropriate criminal proceedings against such candidates may kindly be initiated and the Board may kindly be kept informed.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates whose recommendation is released by the Selection Agency shall submit their Personal Verification Rolls (PVR) before the appointing authority within a period of 21 days from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
