Kindly refer to this office letter No. JKSSB-Scry/2/2024-03 (E-7390977) dated 24.06.2024, where-under the Waiting List for the post of Junior Engineer (Civil), advertised vide Notification No.06 of 2022 dated 11.11.2022, UT Cadre was forwarded to Public Works (R&B) for further course of action.

In the said Waiting List, among others, the recommendation in respect of the following 04 candidates was also kept withheld on account of various deficiencies, with the advice to submit the requisite documents/ certificates within a period of one month.

In response, all the four (04) candidates submitted requisite documents/ certificates, which were subsequently, placed in 296<sup>th</sup> Board Meeting held on 03.02.2025, and the Board took note of the record placed before it and decided to release their withheld recommendation.



Accordingly, the undersigned is directed to convey the above decision of the Board to release the withheld recommendation of above four (04) candidates for the post of Junior Engineer (Civil), Public Works (R&B) Department, advertised vide Notification No.06 of 2022, dated 11.11.2022, with the request to proceed in the matter accordingly.

The above shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction. This Selection List shall also be subject to the outcome of any Inquiry, involving candidate (s), figuring in this Selection List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/ Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/ Appointing authority. The Selection of the candidates has been made on the basis of Self declaration/ Certificates submitted by them, and if at any stage, it comes to the light that, any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, such selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate(s) may kindly be initiated.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates, whose recommendations are released by the Selection Agency, shall submit their Personal Verification Rolls (PVR) before the appointing authority within a period of 21 days from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
