Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid 01 post, among other posts, vide Advertisement Notification No.01 of 2021 dated 03.02.2021, under Item No. 018; and

Whereas, the Final Selection List for the posts of "Driller" under Item No. 18 (Driller, District Cadre, Udhampur), of Jal Shakti Department, Advertisement No. 01 of 2021 Dated 03.02.2021, among other post of the domain, was notified vide Notification No. JKSSB/Sel/Secy/2023/968-77 dated 20.10.2023; and

Whereas, the wait list in the instant selection was not forwarded along with the select list, as per Regulation 68 of the Jammu and Kashmir Service Selection Board (Business and Procedure) Regulations, 2022, which provided that in respect of the Combined Selections the Board has to maintain a category-wise Combined Waiting List with it and forward the same to the Indenting Department as and when requested by it. Also, as the practice of drawing up and forwarding the wait lists was discontinued owing to the issuance of S.O. 496 dated 26.09.2023, which omitted sub rule (7) of rule 14 of the Jammu and Kashmir Civil

Services (Decentralisation and Recruitment) Rules, 2010, which provided for the drawing of wait lists and the procedure thereof; and

Whereas, the Jal Shakti Department, vide its letter No. JSD/99/2023-07-JSD/7349944 dated 16.04.2024, have requested to furnish the wait list for the post of Driller, Item No. 018 (District Cadre, Udhampur), notified vide Advertisement No. 01 of 2021 dated 03.02.2021, in light of S.O. 137 dated 28.02.2024 issued by the General Administration Department; and

Whereas, vide S.O. 134 dated 28.02.2024, the earlier omitted sub rule (7) of rule 14 of the Jammu and Kashmir Civil Services (Decentralisation and Recruitment) Rules, 2010, has again been added to the mentioned rules, to which the effect has been given retrospectively, i.e., from 26.09.2023 (the date of the omission of the said sub-rule) and also vide S.O. 137 dated 28.02.2024, the Board was directed to draw up wait list(s), in respect of those select list(s) which have been issued after 07.09.2023, within a period of six-months, subject to the following conditions; namely:

- (i) That such wait list(s) are drawn within the validity period of the select lists; and
- (ii) That the resultant vacancies on account of non-joining of selected candidates have not been re-advertised.

Whereas, the proposal for issuing the said wait list, as per extant rules, was discussed by the Board in its 269th Board Meeting held on 03.05.2024, which after deliberations approved the notification of the aforesaid wait list.

Now, therefore:

- (i) Consequent upon the receipt of the above-mentioned directions from the General Administration Department and as per the specific request from the Indenting Department, the Wait List for one post of "Driller" under Item No. 18 (Driller, District Cadre, Udhampur), of Jal Shakti Department, Advertisement No.01 of 2021 Dated 03.02.2021, is hereby notified as **Annexure-A** to this Notification.
- (ii) The Wait List shall be subject to the outcome of writ petition(s), if any, pending in any Court of Law of the competent jurisdiction.
- (iii) The Wait List shall also <u>be subject to the outcome of pending inquiry</u>, if any, involving candidate(s), figuring in this Selection List.
