Subject: SWP No. 528/2019 titled Renu Rajput V/S U.T OF J&K and Others.

WHEREAS, the Jammu and Kashmir Services Selection Board vide Advertisement Notice No. 06/2017 dated 28.12.2017, Item No. 026 under SRO 202 invited various applications inter-alia for the post of Science/Maths Teacher, District Cadre Udhampur, School Education Department with the following breakup:- OM=21, RBA=07, SC=03, ST=04, ALC=01, Total= 36

WHEREAS, the prescribed qualification for the said post is:-

“Graduation degree with Physics or Chemistry or Mathematics or Zoology or Botany as one of the subjects in all the Semesters/ Years of the graduation, from a recognized University. Those Possessing five years integrated PG degree in one of these five subjects are also eligible to apply”

WHEREAS, the prescribed Criteria adopted by the Board for the aforesaid post is as under:-

Out of total 100 points, 85 points for a multiple choice based written test and 15 points for preference to B.Ed/M.Ed and higher qualifications. The said 15 points shall be awarded across the board as the following break-up:-

B.Ed=05 points,
M.Ed= 05 points,
P.G (2 Years) or Integrated PG (5Years) = 2 Points
M. Phil=1 point
Ph.D (after M. Phil) =2 points, if direct Ph.D (3 points)

WHEREAS, the J&K Services Selection Board after completion of the selection process, issued the Selection List for the aforesaid post and the same was forwarded to the Indenting/ Administrative Department vide Communication No. SSB/Secy/Sel/11/2019/1644-50 dated 08.03.2019; and

WHEREAS, the Candidate/ Petitioner (namely Renu Rajput who had applied for the aforesaid post of Science/Maths Teacher, District Cadre Udhampur under RBA Category) feeling aggrieved of above said Selection List, approached the Hon'ble High Court, Jammu by way of SWP No. 528/2019 titled Renu Rajput V/S UT OF J&K and others seeking following reliefs:-

“writ of mandamus so as to quash the Selection of the respondents No. 4 to 9, selected over and above the petitioner being less in merit by the respondent No. 2 and so their selection remaining both illegal.

Writ of Mandamus directing the respondents No. 1 and 2 to include 05 points of the petitioner on account of her additional qualification of B.Ed ignored by the respondent No.2 in the determination of her merit qua the selection of the candidates in RBA Category for which petitioner qualifies and remains entitled there under.

WHEREAS, the Hon'ble High Court, Jammu vide its interim order dated 19.03.2019 passed in SWP No 528/2019 titled Renu Rajput V/s State and others issued the following directions:-

“....one post of Teacher under RBA category, District Cadre Udhampur notified vide notification dated 28.12.2107 shall not be filled up. It would, however, be open to the Respondent-Board to consider the pending representation of the petitioner and take a decision thereon by or before the next date of hearing.”

WHEREAS, the Hon'ble High Court, Jammu vide its order dated 05.02. 2020 disposed of the petition with the following directions:-

“In view of the aforesaid factual position, it would be travesty of justice, if the petitioner is denied advantage of five additional points which she would get as per the Selection criteria for having B.Ed qualification.

1o. Having held thus, this writ petition is allowed. The respondents are directed to give additional points to the petitioner for her B.Ed qualification and, accordingly, recommend her name for appointment against the post of Teacher (Maths) under RBA Category, which was reserved by this Court vide order dated 19. 03.2019. Let needful be done and appropriate recommendation be made by the SSB within a period of four weeks from the date certificate copy of this order is made available to the SSB. The Department of Education shall, without any further waste of time, and in any case within four weeks, from the date of receipt of

recommendations from the SSB, issue order of appointment in favour of the petitioner. The appointment of the petitioner against the aforesaid post shall be retrospective with effect from the date the other candidates under RBA category have been appointed. The retrospective appointment shall qualify for all benefits except monetary benefits."

WHEREAS, the petitioner (Renu Rajput) secured 34.4479 points which include 05 points of M.Ed and 02 points of P.G but was not given 05 points of B.Ed qualification as such she failed to make it to the final Selection List under RBA Category on account of inferior merit position in comparison to the last selected candidate under said category having obtained 36.9271 points; and


WHEREAS, the matter was examined by the J&K Services Selection Board in its 174th meeting held on 16th September, 2020 in compliance to the directions of the Hon'ble High Court, Jammu and as per available records in the office of J&K Services Selection Board and it was decided to award five points of B.Ed to the Candidate/petitioner and if after consideration of her B.Ed points she falls in selection zone, her candidature may be recommended to the Indenting department by way of detailed speaking order; and

WHEREAS, after awarding five points to her B.Ed qualification, it was found that petitioner comes under consideration zone with 39.4479 points and will figure at serial no. 02 under RBA Category. However, the last cutoff under RBA Category is 36.9271 which is much less than the petitioner;

WHEREAS, the J&K Services Selection Board vide communication No. SSB/Legal/5599-5602/2020 dated 17.12.2020 requested the School Education Department to intimate whether one post of Science/Maths Teacher, District Cadre Udhampur pursuant to Advertisement No. 06/2017 dated 28.12.2017, Item No. 26 is available/vacant in order to comply with the directions dated 05.02.2020 passed by the Hon'ble High Court, Jammu and in response thereto, the Chief Education Officer, School Education Department, Udhampur vide communication No/CEOU/Legal/46174-76 dated 31.12.2020 submitted that one post of Teacher under RBA category for the post of Maths/Science Teacher is vacant due to non-joining of the candidate pursuant to Advertisement No. 06 of 2017 dated 28.12.2017 in respect of Selection list No. SSB/Secy/Sel/11/2019/1644-50 dated 08.03.2019, District Cadre Udhampur; and

Now, therefore, in deference to Judgment/order dated 05.02.2020 passed by the Hon'ble High Court in SWP No 528/2019 titled Renu Rajput V/s State and others and as per the decision of the Board, the petitioner namely **Renu Rajput D/o Gandeep Singh R/O Blandh, Tehsil Ramnagar, District Udhampur** is hereby recommended to the Indenting Department for appointment against the post of Science/Maths Teacher, District Cadre Udhampur, School Education Department under RBA Category pursuant to Advertisement Notification No. 06 of 2017 dated 28.12.2017, Item No. 026 against available post. The Merit position of the petitioner who will figure at Serial No. 02 under RBA Category after giving weightage (05 points) to her B.Ed Degree with total points 39.4479 as per Selection List already forwarded to the Indenting department vide communication No. SSB/Secy/Sel/11/2019/1644-50 dated 08.03.2019 is enclosed herewith as **Annexure-A**. Further, the candidate already figuring at S. No. 02 will now figure at S.No. 03, and the candidate figuring at S.No. 03 will now figure at S.No. 04 so on and so forth. However, the terms and conditions will be same as communicated to the Indenting Department vide Communication No. SSB/Secy/Sel/11/2019/1644-50 dated 08.03.2019.


